



Proposal Requests

Cellectar Biosciences is committed to academic partnerships that advance high-quality pre-clinical and clinical oncology research and support our drug development plans. Support – both research funding and compound supply - is awarded at the sole discretion of Cellectar Biosciences and must comply with the *Terms and Conditions* outlined below. *N.B. For the University of Wisconsin – Madison, terms and conditions have been previously negotiated under the existing Cellectar-UW MTA and are available for review upon request.*

Terms & Conditions

1. **Rationale:** The proposed research must address legitimate medical or scientific questions that affect the use of a Cellectar Biosciences agent and produce results that can lead towards future evaluation.
2. **Sponsor:** The applicant must be qualified and capable of conducting the proposed studies in compliance with all relevant institutional, state and national regulatory requirements and must not be the subject of any legal or regulatory restrictions or sanctions. The research must be designed to meet ethical guidelines concerning animal use, if applicable.
3. **Scientific Validity:** The proposed methods must be expected to accomplish the stated objectives of the proposed research.
4. **Financial Support:** Funding requests must reasonably reflect the cost and effort involved and must not be used to defray normal operating expenses that are not directly related to the supported research. An executed agreement must be in place prior to release of funds and commencement of proposed research. Cellectar Biosciences will typically limit indirect costs to 15% of requested direct costs.
5. **Publication or Research:** Research results will be collected and analyzed and an annual progress report shall be provided to Cellectar Biosciences. Prepared manuscripts, abstracts and other oral or written disclosures will be provided to Cellectar Biosciences for comment a minimum of one month prior to disclosure. If requested by Cellectar Biosciences, disclosure of research results may be delayed up to an additional 60 days to allow for filing a patent application.
6. **Inventions:** New inventions or discoveries made in the course of the conduct of the proposed research shall be solely owned by Cellectar Biosciences and the applicant (and/or their institution in accordance with institutional policy) will assign its entire right, title, and interest to Cellectar Biosciences.

Two application types will be considered: **Compound Request** and **Research Funding Request**. All applications should be prepared in English and must be provided *via* email as a single PDF. Pre-clinical applications should be forwarded to Marc Longino, PhD (mlongino@cellectar.com). Clinical applications should be forwarded to Kate Oliver (koliver@cellectar.com). Text should be formatted in at



least 10-point font. Subsection maximum lengths are provided below. Cellecstar Biosciences may provide review comments with its decision but this should not be expected. Decisions will generally be made within 30 days of receipt.

Compound Requests will be evaluated by Cellecstar Biosciences and should be made in the following format:

1. Requested Material (compound identification, amount)
2. Proposed Research
 - a. Principle Investigator Biosketch, current NIH format (4-5 pages)
 - b. Principle Investigator Contact Information (0.25 page)
 - c. Background & Significance (0.5 page)
 - d. Specific Aims (0.5 page)
 - e. Research Plan with Timeline (1 page)
 - f. Anticipated Results (0.5 page)

Research Funding Requests will be evaluated by Cellecstar Biosciences and should be made in the following format:

1. Requested Material (compound identification, amount)
2. Proposed Research
 - a. Principle Investigator Biosketch, current NIH format (4-5 pages)
 - b. Principle Investigator Contact Information (0.25 page)
 - c. Background & Significance (1 page)
 - d. Specific Aims (1 page)
 - e. Preliminary Data (1 page)
 - f. Research Plan with Timeline (3 pages, this should include a reasonably detailed Methods section)
 - g. Biostatistical Plan (1 page)
 - h. Budget (1 page)

If a **Compound Request** or **Research Funding Request** is approved by Cellecstar Biosciences, the applicant will alert their institutional Intellectual Property representative for preparation of an appropriate Research Agreement.
